
## **Insights from the Bitvo Trading Desk**



At the risk of sounding like a broken record, the price of Bitcoin topped previous all-time highs yet again last week, touching the milestone US\$50,000 level. Similarly, the price of Ether rose, almost touching US\$1,900. Supporting these moves higher were many announcements from traditional financial institutions, large U.S. cities (New York, Miami), notable names such as Twitter's Jack Dorsey and rapper Jay-Z as well as continued corporate buying and the approval of the first publicly traded Bitcoin ETF right here at home in Canada by the Ontario Securities Commission. Total market capitalization of cryptocurrencies globally is now US\$1.5T, of which Bitcoin comprises US\$900B and Ether comprises US\$200B.

#### Altcoin Headlines

- After leading the way in Bitcoin and Ether trusts, digital asset manager Grayscale Investments filed to register a new crypto trust for DeFi platform Yearn Finance (YFI) last week.

### Other Newsworthy Bits

- The Ontario Securities Commission approved the first publicly-traded Bitcoin ETF in North America last week, the Purpose Bitcoin ETF, managed by Purpose Investments to replicate the performance of the price of Bitcoin minus fees and expenses. While Purpose's ETF is first, more are expected in the coming months including from Evolve Funds Group Inc., Horizons ETFs Management (Canada) Inc., Arxnovum Investments Inc., and Accelerate Financial Technologies Inc.
- South of the border, crypto-focused asset manager and index provider Bitwise filed a prospectus with
  the Securities Exchange Commission (SEC) for the Bitwise Crypto Innovators ETF, which will track the
  performance of companies included in the Bitwise Crypto Innovators Index (assembled by Bitwise
  Index Services).
- Jay-Z and Jack Dorsey, CEO of Twitter and Square, established an endowment to fund Bitcoin development. They invested 500 Bitcoin (worth approximately US\$25 million) initially.
- Miller Value Funds, run by veteran hedge fund manager Bill Miller, became the latest traditional financial institution to include Bitcoin as an eligible investment in its fund.
- Two major U.S. cities, New York and Miami, are vying to become cryptocurrency-friendly hubs. New York City mayoral candidate Andrew Yang announced that he intends to make the city a "hub for Bitcoin and other cryptocurrencies" if elected. Meanwhile, Miami's mayor Francis Suarez proposed an initiative that would allow city employees to be paid in Bitcoin and for it to be accepted as a means of payment for city taxes, potentially paying the way for the city to hold it in its reserves.
- As Bitcoin miners collected a record single-hour revenue of US\$4.05M on February 11<sup>th</sup>, Bitcoin mining companies continued to raise money to expand operations with Canada's Bitfarms raising over US\$30 million in its third private placement issued in as many months.
- RBC Capital Markets research analyst Mitch Steves noted that it would be a smart strategy for Apple to
  enter the crypto business, perhaps by creating a cryptocurrency exchange. Creating a cryptocurrency
  business could "potentially create US\$50 to US\$80 billion in equity value", according to Steves.
